# Narendra Modi govt. has 'strangled' democracy: Sonia

Never had so many parliamentarians been suspended for a 'legitimate demand' that the Home Minister should make a statement on, she says

The Narendra Modi government has "strangled" democracy and the Prime Minister had shown his "disdain" for Parliament, Congress Parliamentary Party (CPP) Chairperson Sonia Gandhi said on Wednesday, referring to the face-off between the Opposition and the government over the December 13 security breach in the Lok Sabha.

Ms. Gandhi made these remarks while addressing her party colleagues from both Houses of Parliament in the Central Hall of the old Parliament building. She said never had so many parliamentarians been suspended for a "legitimate demand" that the Home Minister should make a statement on the security breach in the Lok Sabha.

The CPP Chairperson said that it took four days for the Prime Minister to speak about the issue and that too outside Parliament.

"By so doing, he [Mr. Modi] clearly indicated his disdain for the dignity of the House and his disre-

garded for the people of our country. I leave it to you to imagine how the BJP would have responded had they been in Opposition today," Ms. Gandhi said.

### Bills on J&K

Noting that Parliament had passed some important Bills relating to Jammu & Kashmir, Ms. Gandhi said the Congress position was to press for restoration of Statehood, hold immediate elections and meet the aspirations of the people of Ladakh.

Ms. Gandhi also accused the government of "distorting history and twisting facts" to defame patriots such as Jawaharlal Nehru.

"In these efforts, the Prime Minister and the Home Minister have taken the lead themselves, but we will not be intimidated

or cowed down. We will persist in telling the truth," she said.

The former Congress chief also said that there is a "significant gap" between the Prime Minister's boasts about economic growth and the ground reality.

"Unemployment is soaring higher than in decades, and wealth is being concentrated in the hands of a select clique of industrialists. Prices of everyday commodities are skyrocketing. The poor are suffering," she said.

Ms. Gandhi referred to the recent loss of the Congress in the Assembly elections in Chhattisgarh, Madhya Pradesh and Rajasthan, and said that to say that it had been very disappointing was "an understatement".

The former Congress chief once again reiterated the party's position that the women's reservation law must be implemented immediately and should cover women from the Other Backward Classes.

She also targeted the BJP for weakening the co-existence of diverse religions, castes and ethnicities that make up the social fabric.

# President, PM express dismay over Dhankhar mimicry; Rahul hits back on MPs suspension

The issue of Trinamool Congress MP Kalyan Banerjee mimicking Vice-President Jagdeep Dhankhar snowballed into a major controversy on Wednesday, with President Droupadi Murmu and Prime Minister Narendra Modi expressing their disapproval to the act publicly.

Congress leader Rahul Gandhi, who was targeted by the BJP for filming Mr. Banerjee's act on his phone, hit back by saying that he shot the video of MPs sitting outside Parliament and asked "why is there no discussion [in the media] over 150 [Opposition] MPs being thrown out of the House".

In a rare public comment on a developing political debate, Mr. Murmu, in a post on X, said she was dismayed to see the manner in which the Vice-President was humiliated in the Parliament complex.

"Elected representatives must be free to express themselves, but their expression should be within the norms of dignity and courtesy. That has been the Parliamentary tradition we are proud of, and the People of India expect them to uphold it," Ms. Murmu said.

The Vice-President's Secretary also put out a post on X to inform that Mr. Modi had called Mr. Dhankhar to express "great pain over the abject theatrics of some Honourable MPs and

that too in the sacred Parliament complex yesterday".

"He told me that he has been at the receiving end of such insults for 20 years and counting but the fact that it could happen to a Constitutional office like the Vice-President and that too in Parliament was unfortunate," Mr. Dhankhar

was quoted as saying in the post.

Lok Sabha Speaker Om Birla also met Mr. Dhankhar to express his concern about the "serious misdeemeanour" by some MPs in Parliament complex.

As the mimicry issue played out both inside and outside Parliament, the Congress said the "entire Modi ecosystem" was now being galvanised on the "so-called mimicry non-issue" while it remained silent on how BJP MP Prathap Simha "facilitated" the entry of two intruders into the Lok Sabha.

Congress leader Jairam Ramesh also shared an old video of Mr. Modi mimicking someone inside the Lok Sabha.

In the eye of the storm,

Mr. Kalyan Banerjee said he did not intend to hurt anyone with his act and insisted that he had not named anyone.

"I have not taken anyone's name. If he has taken it upon himself, then I am really helpless. I have never any intention to hurt anyone," Mr. Kalyan said.

West Bengal Chief Minister and Trinamool Congress supreme Mamata Banerjee, who was in the Parliament complex to meet the Prime Minister, played down the incident while backing her party colleague.

However, Mr. Kalyan was not part of the Trinamool delegation that met Mr. Modi even though he was scheduled to be part of it.

# BJP, Congress trade barbs over mimicry row

The Bharatiya Janata Party (BJP) and the Congress faced off against each other on Wednesday over a mimicry of Vice-President and Rajya Sabha Chairman Jagdeep Dhankhar by Trinamool Congress MP Kalyan Banerjee, which was perceived as an insult to the Jat community.

On Tuesday, as the video of the act went viral on social media, Mr. Dhank-

har referred to it in the Rajya Sabha. Addressing the Opposition benches, he said, "You [Congress] used the official Twitter handle of the spokesperson to demean me, insult me, insult my background as a farmer, my position as a Jat, insult my position as a Chairman."

Parliamentary Affairs Minister Pralhad Joshi on Wednesday condemned the act. Speaking in the Rajya Sabha, he said: "For the first time a farmer's son of

the Jat community has risen to occupy such a high constitutional office, but they [Opposition] have been insulting this constitutional position also."

The Congress was quick to respond on the issue, with party president Mallikarjun Kharge saying that "caste should not be dragged into every issue".

"I am not allowed to speak in Rajya Sabha often. Should I say it is because I am a Dalit," Mr. Kharge said, adding that they

should not incite people outside in the name of caste by talking about it inside.

Congress MP Randeep Surjewala, who belongs to the Jat community, pointed to the farmers' protests being put down by the government and the use of pejorative terms by BJP members.

He also raised the issue of two women wrestlers from the Jat community who had held protests against a BJP MP.

"Those in high positions should reflect on what is the yardstick of dignity of high office. Whether they are President, Vice-President, Prime Minister or any constitutional post holder, they are above caste and their duty is to uphold the Constitution," he said.

Meanwhile, a Jat community group, the Palam 360 Khap, called a meeting of its members and threatened to organise protests unless Mr. Banerjee tendered an apology.
